Jessica – this is an agreement that will have two weeks of severance pay and payout of vacation, personal and comp time for the dispatchers based on the shared service agreement we have starting September 1st.

- Jessica Absecon reached out to the County to join the County Library System because our director is retiring. Faced with new guidelines for the position of library director, it was discussed that we can't afford to hire someone with the required credentials without a substantial increase to the budget and then an increase in taxes. It's a good time to do this, since the county is equipped to maintain a branch here with expanded hours and other additional services. They will take over beginning Oct. 1st.

 Linda Weisbecker president of the Library Board Barbara Wilson will step down from her 45-year of service to the Absecon City Public Library, effective Oct. 1st. She then read a statement of her duties and service for those years. The board has voted to join with the county library system and they feel this is the best and most appropriate time to make this transition. She thanked Barbara for her time and selfless service and the city for its support throughout the years.

 Betty the city owes a great deal of gratitude for a lifetime of dedication to our library here in town
- Jessica this will be a 10-year lease, plus the remaining 3-months of this year with the County for the library building. It belongs to us, so we will continue to be responsible for exterior maintenance and the county will handle any improvements or costs inside the building and the operations. The lease amount is \$31,250 per year, based on \$5.00 per sq. foot of the 6,250 sq. feet of building. The operational costs of running the library will transition to the county budget instead of being part of the municipal budget. The difference in operational costs is approximately \$8,000 per year, net of the rental. The county tax will show an increase and the municipal tax will show a decrease. This will not be reflected in this year's tax bills, but it will in next year's.

REPORTS

Butch - Public Works - no report

Steve – Parks and Playgrounds – they met on July 20th and discussed the lacrosse team who are trying to get their schedule together and the fields they will use. No plan was finalized, but it was started at least. The concerts are going well and have one cancellation. He received a call from Public Works to check on the football field that is being used during the summer for different functions.

Nick - Economic Development - no report

Betty – Public Safety – they met on 8/4 and the ambulance squad reported that they are having a higher-than-normal rate of calls. The firehouse is running smoothly and they are preparing for their open house on Oct. 23rd. The parade will start at the school at noon. Plans are still in the making. The 9/11 event will begin at 2:00 p.m. There will be an open house at the legion afterwards. Speeding in town is still a nuisance and asked residents to slow down. They will meet on 9/13 at 6:00 p.m. She thanked the owners of the Hi Point who donated some steel picnic tables to us.

Sandy – Community Affairs – they met on August 5th and not much is going on. There are still yard signs for sale here at city hall. The book swap went well in July. The 9/11 committee will be having a coin drop on 8/21 between 9 and 2 and there will be coins you can purchase for \$10 and tee shirts as well. The last concert is 8/29 at 4:00 p.m. There will be a Halloween decorating contest again. Her next meeting is September 2nd.

Steve – added that someone should reach out to the legion to see if they want to participate in the last concert to sell snacks. There are supposed to be about 70 musicians in attendance.

Jessica – tax bills should be going out soon and there will be a grace period of 25 days after the mailing. The total tax rate is lower than last year as a whole, so people will see a slight decrease over last year. The recycling cart program is moving along and we expect to have them in late September. Residents will be getting a mailer regarding info on them. It's not increasing taxes, but there is a cost of \$20,000 a year with a grant that we received as well.

She received an email from AC Electric on storm preparedness and stated some of the tips. Officer Keith Epstein wanted to thank everyone for the support that you gave the police department for the first annual Christmas in July movie night.
