124 Appointing a Full-Time Patrol Officer – namely Max Lorenzo.

Police Chief Laughlin - gave a brief background on Max and welcomed him as a fulltime officer. He was sworn in by Mayor Horton.

PRESENTATION - Atlantic County Court Consolidation

Jim Ferguson, county counsel and Mark Sandson, retired Superior Court Judge both appeared on behalf of the County. In 2020, the County Executive approached him with the idea of forming a county-wide regional municipal court. There was a committee put together with representatives from the court system, who sent out invites and they received 17 responses back from towns who would explore the idea. There are commitments from 8 municipalities, which is the minimum to get this started. He then explained how it would work and the work being done on the old criminal court house in Mays Landing that will house the court system. There are significant savings to the city to do this. Spread sheets have been created to show that towns would save between 30-35% over what they are spending now. The agreement is set up for the participating municipalities to have input as well and there will be committees made for certain departments. They would like to have it up and running by January 2022. They reviewed figures for a three-year average and based on that Absecon's annual cost for its court was \$187,500 per year. The revenue average was \$165,700, so based on those numbers we would have a deficit of \$21,000 per year. Under this model, our contribution would be a little over \$95,000 and the savings would be \$94,500.

Using the revenue average, you'd have a surplus of \$71,200. Police officers' appearances would be done virtually, so there is no travel. It would be a two-year commitment and if not happy, you can give 6 months' notice and then you can withdraw. They asked for the city to give this some review.

Mark Sandson – he was asked to work with Jim on this process and explained how the process would work. There wouldn't be long lines of people waiting for their case to be heard and sometimes getting rescheduled; cases will be assigned times. He knows Absecon's court is a good one, but having 16 s0eparate courts in the county, doesn't make sense. This process shares the taxpayer's money and there will be more benefits to them. There is no downside to this and it saves the city money.

Council President, Howell – wanted more information on how it will help the mentally ill Mayor Horton – doesn't see how this could be a good thing for Absecon and with the manpower you will need, she feels our county taxes will go through the roof.

Mark Sandson – you're going to save about \$100,000 for the city.

Jessica Thompson, Admin./CFO - stated the numbers for us Jim - he doesn't know how the numbers came about and maybe the county and the city looked at different things when coming up with the costs, but he still thinks the city would see a savings by joining.

Discussion went back and forth regarding the expenses and savings. Steve likes the County's efforts with helping people with different problems and issues.

Chief Laughlin – asked the residents to keep in mind that they get calls daily regarding speeders and patrol is sent to those specific areas. Our small town isn't so quiet anymore, so by adding all the new residences, the traffic has gotten worse, so he asked everyone to be patient.

Chief Laughlin – we will be following the laws of the state and if you have an issue, you should contact your legislatures. We can't violate anybody's rights and have a lot of extra litigation on our end.

Greg – asked Betty if they could look into some of the ordinances on parking and uses downtown that the Planning Board had suggested. Also encouraged council to put the meeting recordings on YouTube at all times. It's free and easy to do and someone could watch whenever.

CLOSED SESSION - #129 - Litigation

Attorney Fred Scerni – stated closed session is needed to discuss pending litigation. We have returned to public session and in closed session council discussed certain pending litigation and they met with two attorneys who are representing the city in the current litigation. They received an update as to the current status and possible settlement strategies that are being discussed. Council shared their opinions with these attorneys who will now undertake their position and go further with this litigation.
